RE: Transition of all Tulsa and Eastern employees to Green Country Workforce

It is our desire to ensure our previous commitment to a seamless transition for all board staff from Tulsa and Eastern Workforce regions, to ensure full engagement and uninterrupted services to the residents of our counties, and to make sound fiscal decisions; therefore, we the Local Elected Officials of Green Country Workforce Development Board approve the following:

- All Board employees from both regions will retain their original Hire Dates and credit for previously earned Years of Service.
- Previously earned and recorded balances for Vacation Leave will be cashed out on the last paycheck administered under COWIB and Eastern processes.
- Previously earned and recorded balances for Sick Leave will be transferred with employees to Green Country Workforce records.
- Per the agreement of the Green Country Workforce Board Executive Committee, severance
 payments will not be made to employees who transition to full-time roles with no loss of
 compensation.
- Employees of the former Eastern Workforce Investment Board will be offered the option to take severance in lieu of transition to employment and with a signed waiver and release of claims.
- Former EWIB employees who elect severance will be separated without prejudice and will be able to apply for future posted positions for which they believe they are qualified.

In approving these actions, we assert that Green Country Workforce Development Board should be held harmless in relation to their agreement to offer the choice of severance and pay Vacation Leave balances without an associated separation of service and in the absence of precedent.
