Youth Program

I. Policy Statement: WIOA outlines a broader youth vision that supports an integrated service delivery system and provides a framework through which states and local areas can leverage other Federal, State, Local, and philanthropic resources to support in-school youth (ISY) and out-of school youth (OSY). Green Country Workforce Development Board (GCWDB) affirms the Department of Labor’s commitment to providing high quality services for all youth and young adults, beginning with career exploration and guidance, continued support for educational attainment, opportunities for skills training in in-demand industries and occupations, such as pre-apprenticeships or internships, and culminating with a good job along a career pathway, enrollment in post-secondary education, or a Registered Apprenticeship. All of the Department’s youth-serving programs continue to promote evidence based strategies to assist in achieving high-levels of performance, accountability, and quality in preparing young people for the workforce.

II. Youth Council: GCWDB will maintain a standing youth council which will be comprised of stakeholders from the community, board members and staff.

III.
